IMPORTANT PRICING CHANGES FOR LATE REGISTRATION OF CHAPTER MEETINGS

Dear Fellow Members of CAHF,

We are fortunate here in Orange County to enjoy one of the most vibrant and involved Chapters in the statewide system of 19 Chapters. This commitment to the membership of the Orange County region is a reflection of the outstanding leadership we've had over the years in our Chapter. The mission is and has always been to be responsive to the membership we serve, to provide information & education on the topics critical to operators, and to do so in a cost-effective manner.

After careful consideration and critical cost-accounting of the expenses associated with our quarterly education meetings, it has become clear that the costs associated with those attendees who did not pre-register & pre-pay prior to the pre-registration deadline, is significantly more than those who do pre-register & pre-pay. In order to continue to provide an economic value for the majority of those that pre-register & pre-pay at least a week inadvance, we are instituting a couple of changes in pricing & policy.

In addition to the pricing schedule changes you'll see on the pre-registration form, we will also require that payment is received either by PayPal or check prior to the pre-reg deadline. We have been quite lenient in the past, and this flexibility has become more of the rule than the exception, therefore we will not be able to extend the deadline going forward. If not received on time, the rate reverts to the late registration fee price.

Thank you for your understanding of these needed changes, so that we may continue to provide the greatest value for the greatest number of members in our Chapter.
