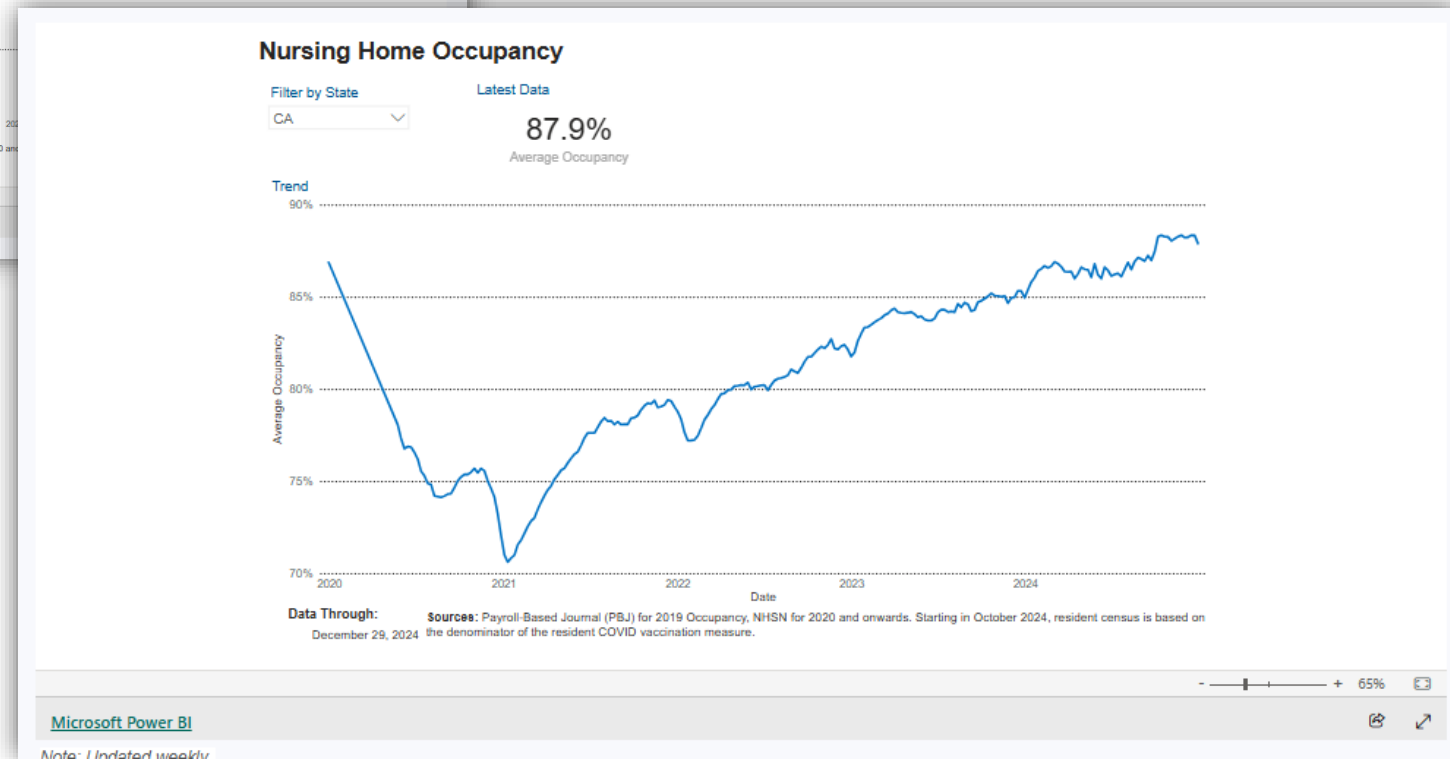
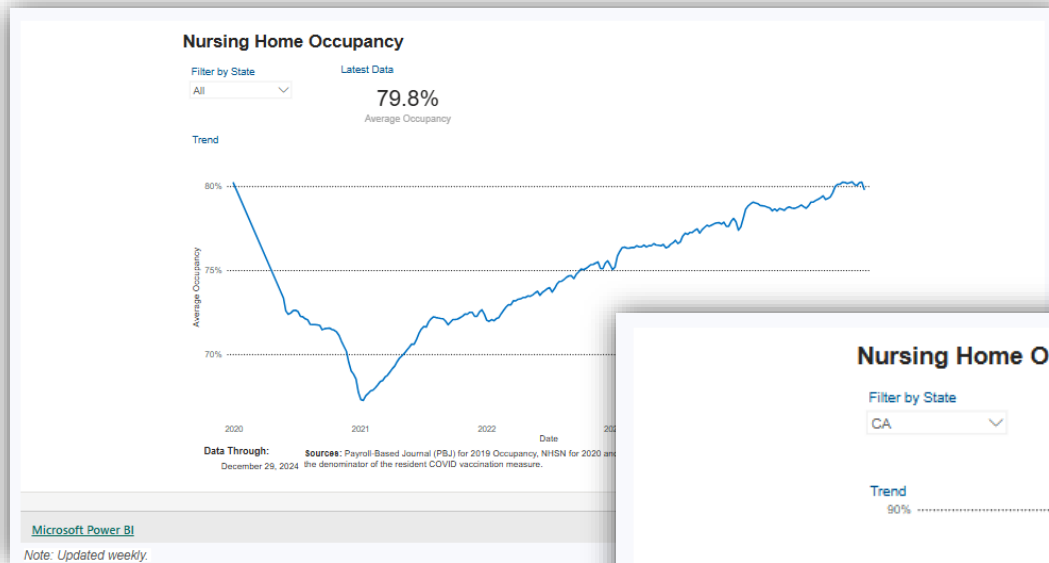

Nation: 79.8%

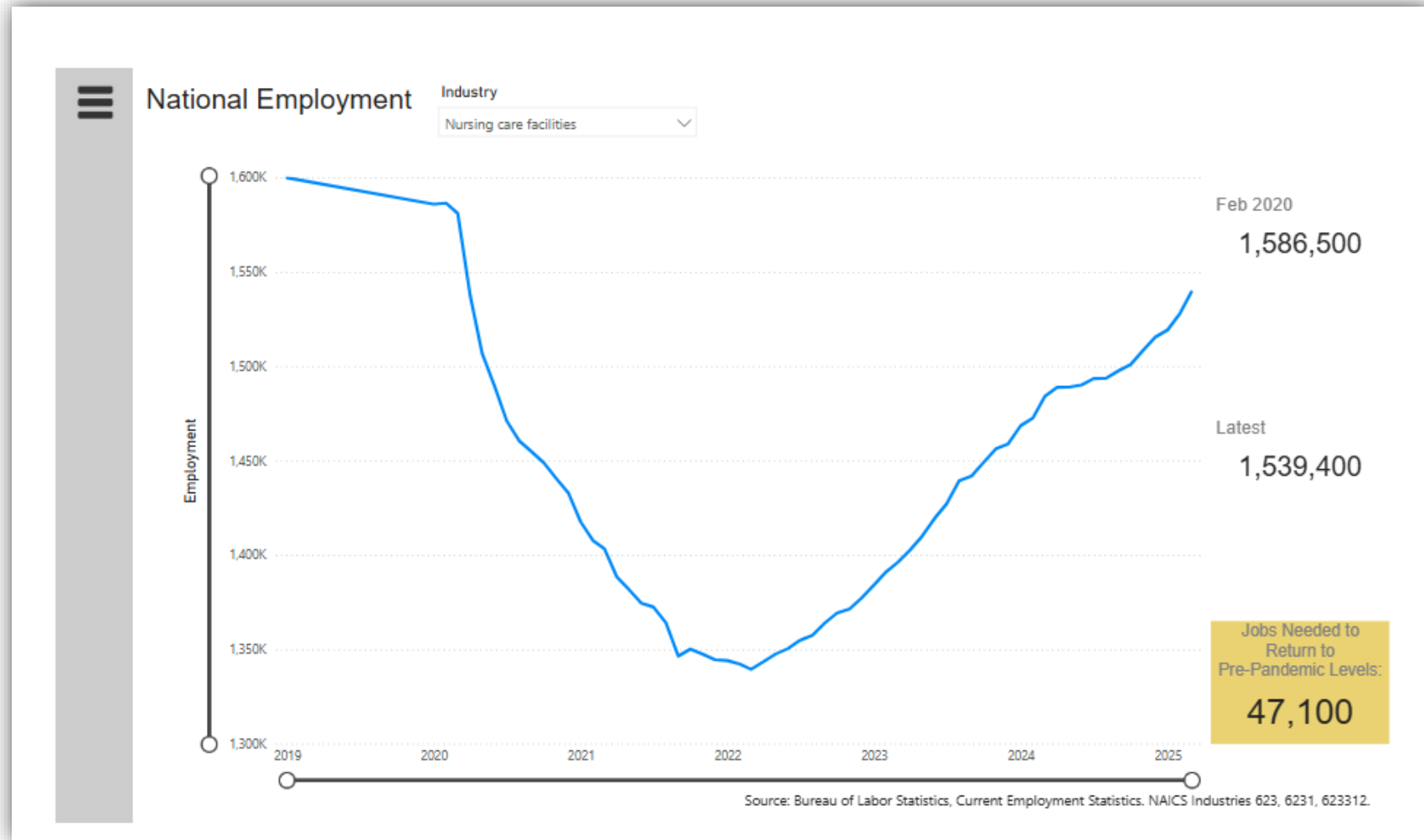
California: 87.9%

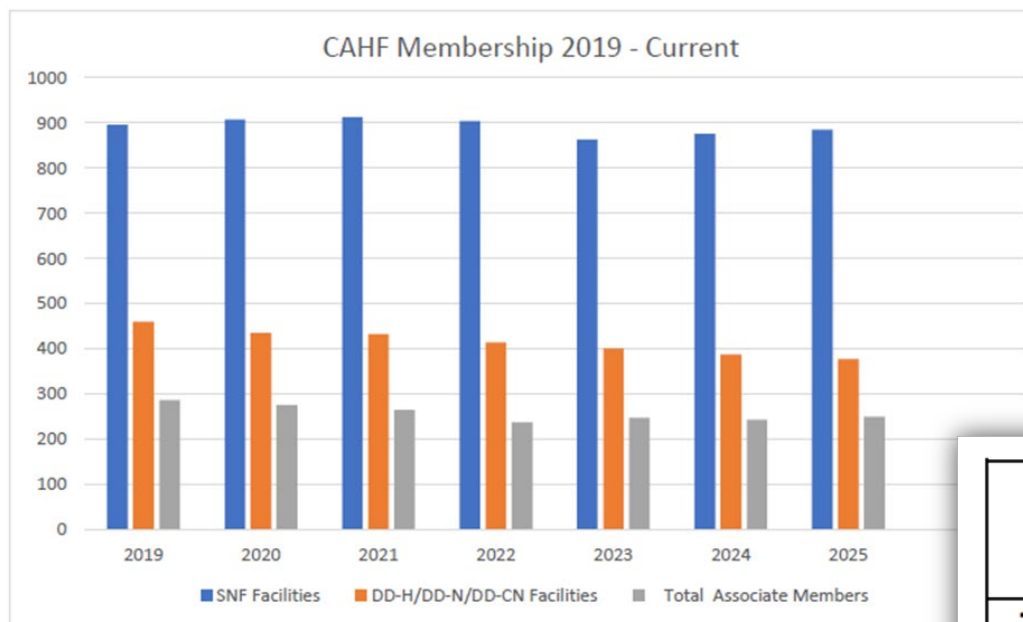

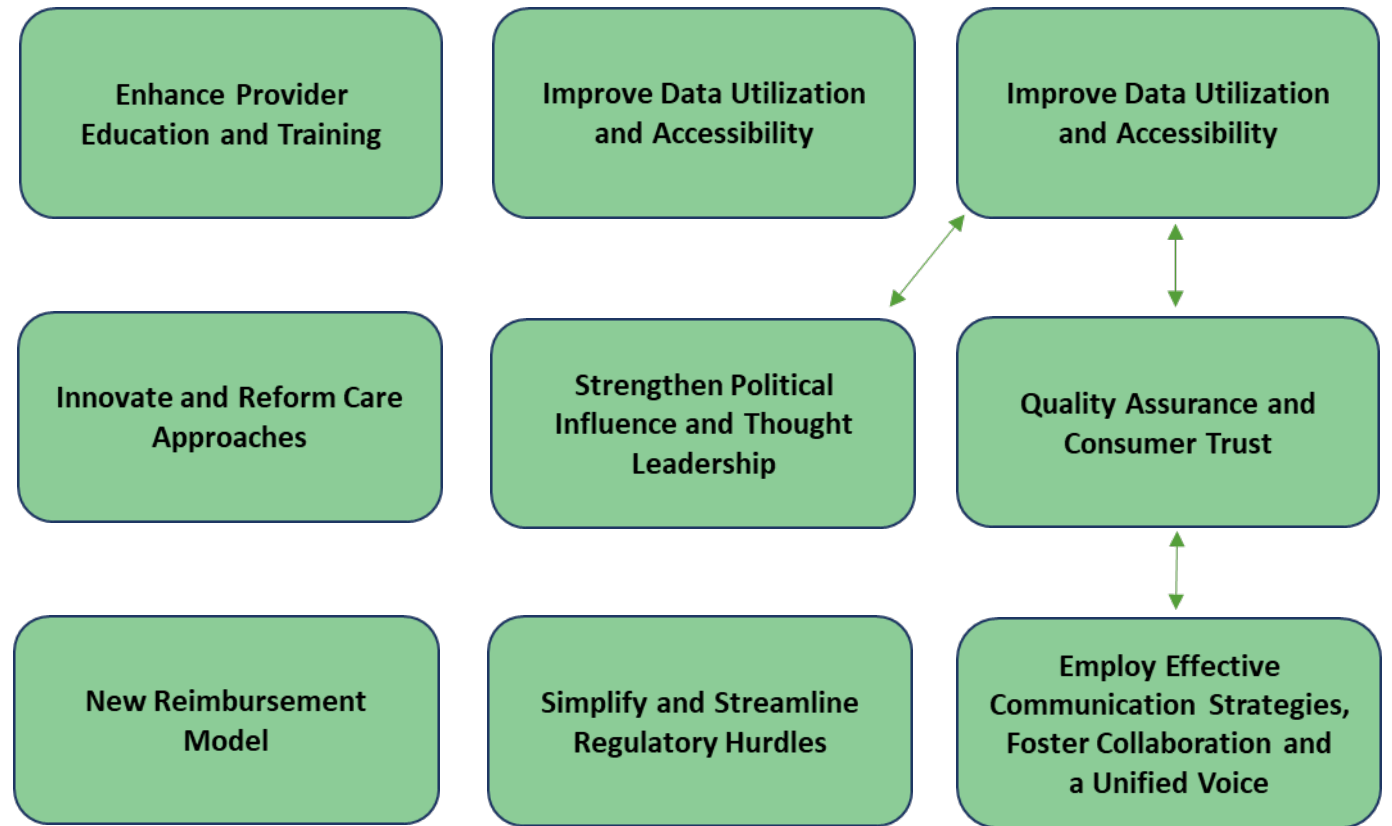

- Dr. Oz confirmation

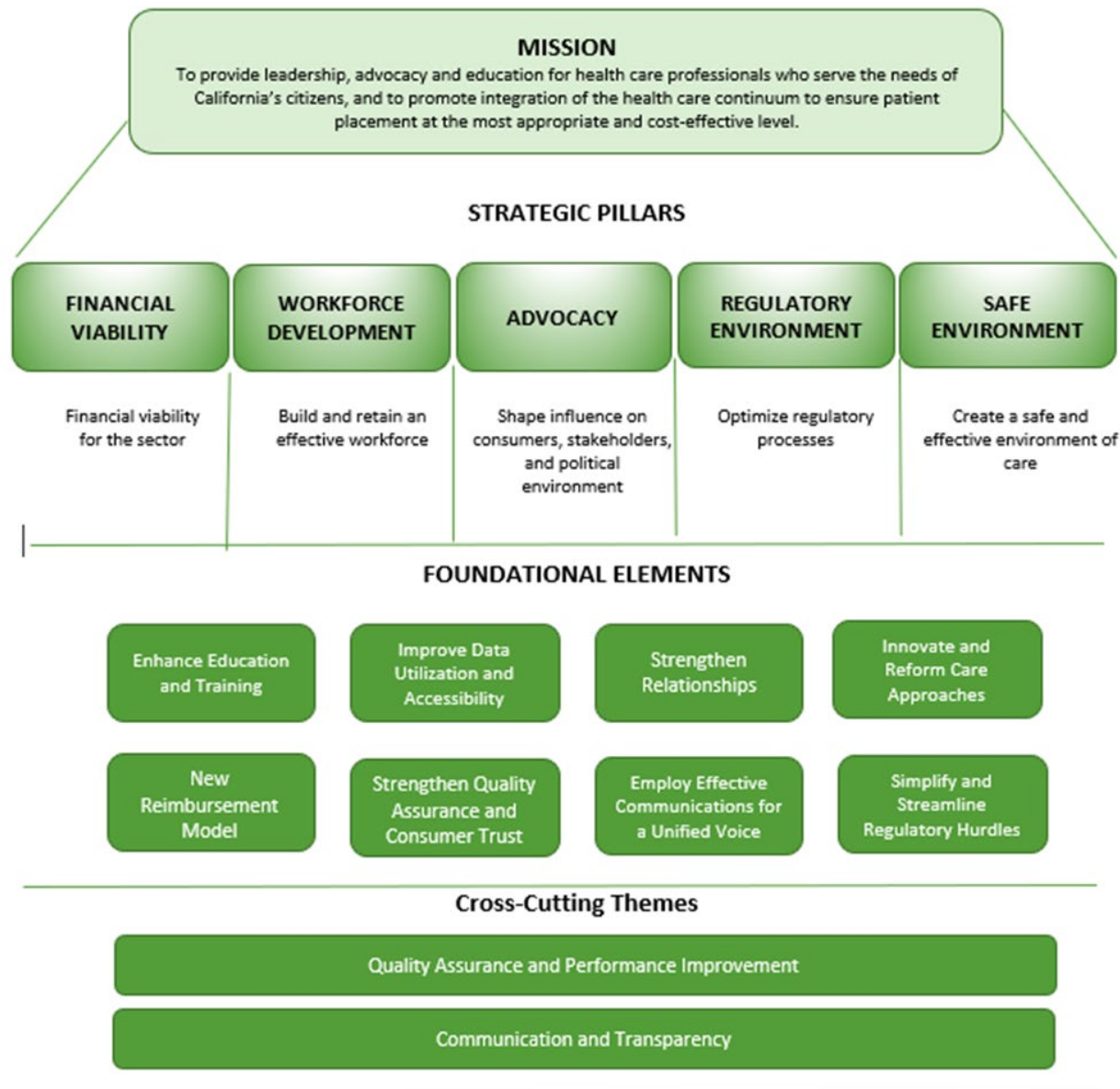
CAHF 2025-2028 STRATEGIC PLAN PRIORITIES

AHCA Strategic Plan

Increase Available Workforce for LTC Providers

1. Defeat minimum staffing rule
2. Advance health care visa legislation/reinvigorate efforts for visa programs
3. Provide resources to members to increase worker recruitment and retention
4. Ensure increased state and/or federal funding for health care worker training programs
5. Advocate for state or federal policies and legislation to support workforce development, promote long term care careers and attract workers

Improve Quality of Care

1. Provide resources for members to improve quality of care and navigate survey process
2. Increase 2026 Quality Award participants
3. Advocate for changes in survey and regulatory process to support quality improvement
4. Increase Assisted Living provider enrollment in the Long Term Care Data Collaborative

2025 3-Year Strategic Plan

Ensure the Economic Health of Sector

1. Defend sector from Medicaid or Medicare cuts by Congress or Administration
2. Stop any unfunded mandate
3. Preserve SNF/AL ability to own & control financial risk and increase number of lives under a population health management arrangement to 150,000 by 2026
4. Seek development of a SNF-specific wage index within the labor market basket rate
5. Advocate for legislation to hold MA plans accountable to beneficiaries and pay providers fair, timely and adequate reimbursement
6. Ensure there is a net increase in the SNF PPS annual payment rule
7. Support State Affiliates in Medicaid Reimbursement Advocacy

Be a Strong Organization

1. Raise \$4.8 million of \$12 million in first of two-year cycle in hard and soft money
2. Maintain membership level and engage new owners
3. Maintain Association reserves of at least 50% of operating budget
4. Increase non-dues revenue from 2024 budget

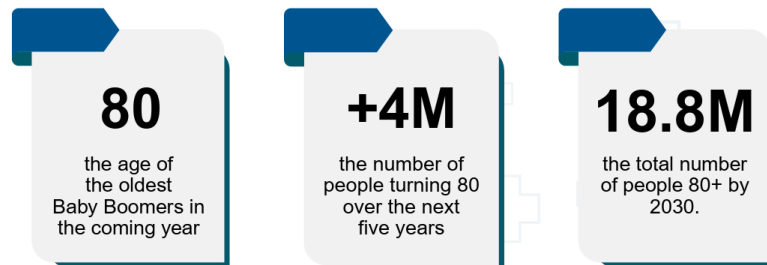

Medi-Cal Funding & Rate Deal

- Consultant agreements
 - Upper Payment Limit (UPL) to include Average Commercial Rate (ACR)
 - Rate Methodology Modeling, Alternative structures
 - Adding VP of Reimbursement to CAHF staff
- DHCS Workgroup expected in July/August
- Master Plan on Aging Goal 1, #34
 - Improve nursing home quality through the continued improvement and innovation of the financial methodologies for Skilled Nursing Facilities.
- Reality of ongoing state budget deficit
 - Explore other funding opportunities
- Rate floors/Rate ceilings & MCPs

Medi-Cal Managed Care

- Workforce Standards Program
 - Managed Care Plans are working on updating the posted rates
 - Prospective Rates: 30 working days
 - Retroactive adjustments: 45 working days
 - Payment or recoupment
 - 5th batch posted on April 11
 - 22 facilities remaining
- Workforce and Quality Incentive Program
 - Coming soon: Webinars from each of the managed care plans
 - Managed Care Plans beginning to schedule webinars, CAHF will share to Forum as we become aware of them
- Interim payment for Program Year 2024
 - Intended for end of March, delayed due to State's pending access to MDS data
 - Expected no earlier than mid-May at this point
 - CAHF checking in weekly on data

Workforce

- The Good News: recovering slowly
- The Bad News: still not at target
 - Growing demands, aging population outpacing our progress
- Initiatives at the national level to recognize LTC HCW as essential, pathways to allow workforce growth & retention (incl. immigration policies)
- Future projections needed for solution design
- CNAP and Federal CMS nursing programs
- Reform of CNATP exclusion criteria

Regulatory Updates

- Survey activity, backlog (47% as of 12/31/24, LAC 51%)
- Voluntary bed suspension issues
- DDPNA (Discretionary Denial of Payment for New Admissions)
- Infection Control Preventionist reclassification
- Regulatory packages:
 - Temporary manager (comments submitted)
 - Unusual occurrences (comments submitted)
 - ICF DD (still pending)
 - Change of Ownership (still pending)
- Compliance with alternative power requirements (AB 2511) \$249M budget
- Reforming the IDR/IIDR process
- Regulatory enforcement in Los Angeles County

Legislation and Politics

- New legislative leadership
- California democratic supermajority
- Budget remains a priority topic for Federal and State spending
- California's relationship with the federal administration
- Government efficiency, cost cutting & fraud focus
- Labor influence
- Federal HHS and CMS appointments

Legislation and Politics

- **Wildfire/Disaster response** – legislation related to LTC facility evacuation, rebuilding, use of emergency generators
- **Transparency** – legislation related to requiring state agencies to more prominently post enforcement actions, wage judgments
- **Visitation** – legislation related to clarifying conditions in which family members can visit residents
- Amendments to previous legislative “deals” – **MICRA, PAGA**
- **Managed Care Plans** – legislation related to MCO approval of prior authorization, denial of claims, timely payment

Legislation and Politics

- AB 2511 – backup power source
 - Trailer bill opportunity for delayed implementation or waiver
- Managed Care and WQIP
- SB 525 Minimum patient care spend, possible split from minimum wage
- Civil liability
- Transparency, positing of data and disciplinary actions
- CAHF Activity:
 - Continued grassroots efforts
 - Member engagement, advocacy, and strengthening relationships
 - PAC/PAF
- AHCA/NCAL Congressional Briefing in DC, June 9-10, 2025
