#### CMS: Emergency Preparedness Requirements

CMS has published expanded disaster preparedness requirements that affect the ICFs/DD, DD-H and DD-N facilities, effective November 2017. Provider trainings opportunities are ongoing. <u>Click her for a copy of Really Ready for information on upcoming trainings.</u>

#### CMS / CDPH: Life Safety Code (LSC)

CDPH began to survey facilities for compliance with the **2012 edition of the LSC on November 1, 2016.** The new requirements include a 'protected' implementation date of July 5, 2019 for the regulation K359 (Sprinklers/Heat Detection in Attics). Currently discussions with CDPH are ongoing for the protected implementation date, as on occasion; LSC Surveyors are requiring an immediate plan of correction. Be familiar with your consumers' evacuation ratings, as the ratings will instruct/guide the Surveyor as to what requirements to inspect on the survey. <u>Click here for information for ratings</u>. <u>Click here for a copy of the LSC workbook</u>.

# **UPDATE - AB 251:** Delay in adoption of regulations for ICF/DD-N and CNC facilities.

AB 251 proposes to extend the scheduled sunset of the 'Department of Public Health' and 'Department of Developmental Services' authority to use federal certification standards for certain types of specialty clinics and health care facilities as the state licensure standards for those types of clinics and facilities. The bill also extends the deadline by which the Departments shall adopt regulations relating to licensure of these types of specialty clinics and facilities. (ICF/DD-N facilities and the ICF/DD-CNC facilities) to **2020**, which is one year longer than originally proposed. The "CNC" facility type began as pilot program in **1999** and converted to a waiver program - currently under the AH/NF waiver of the DHCS and does not have regulations for the classification. There will be no rate setting for this provider category until the regulations have not been resubmitted to the Secretary of State for approval since **1989**. A delay of the sunset date is unreasonable with the history of inability to fulfill the mandate to promulgate regulations for the ICF/DD-N and ICF/DD-CNC facility types.

#### DEPARTMENT OF DEVELOPMENTAL SERVOCES (DDS): Four Bed Model

A proposal for a four bed model to include research for cost and operational processes has been submitted to DDS on April 20, 2017

#### **DEPARTMENT OF HEALTHCARE SERVICES (DHCS): Five Year TAR**

A proposal for extending the re-authorization of a TAR from 2 years to five years has been submitted to the Department on March 1st, 2017.
