These types of adverse events have impacted health care facilities across the nation and all providers must proactively prepare, respond and recover from "The Unthinkable."


This informative and interactive workshop will review some violent incidents that have occurred in LTC facilities and lessons learned. The need to prepare employees of a LTC facility to address this type of peril is directly related to survival. Attendees will learn the critical options that they can consider to survive an active shooter in a health care facility or senior living community. The program will focus on personal safety and the safety of facility residents in a process that is designed to safeguard as many lives as possible. The session will also focus on the need to lead in the absence of leadership when emergencies of this magnitude occur.

The interactive portion of this workshop will feature a facilitated tabletop exercise (TTX) that will give participants the ability to engage in discussions on how to best prepare, respond and recover from violent events that can occur in any type of health care facility.

The workshop will also include a short presentation by one California provider that takes the concept of preparedness to the highest level by equipping its facility with the resources needed to implement an "All Hazards" approach to emergencies and disasters.




